

# STRIP-IT PRO

## HEAVY-DUTY ACID CLEANER

### DIRECTIONS

Strip-It Pro is a unique blend of acids, surfactants and wetting agents which together produce maximum cleaning results on greenhouse or outdoor hard surfaces.

Strip-It Pro removes stubborn mineral deposits such as calcium, magnesium and iron but also attacks organic buildup on hard-packed soils.

Strip-It Pro must be thoroughly rinsed before drying and must not be applied directly on plants, protect plants with plastic covering when over spraying may be possible.

**This product is a concentrate and must be diluted before use. See table below.**

Cleaning Application	Strip-It Pro / Water (fl. oz / gal)
<b>Heavy-Duty Cleaning</b> (e.g., sunblock removal)	<b>8.0 to 12.0</b>
<b>Medium-Duty Cleaning</b> (e.g., interior glass, plastic)	<b>4.0 to 8.0</b>
<b>Light-Duty Cleaning</b> (e.g., irrigation lines, storage tanks)	<b>1.5 to 4.0</b>

**Do not allow Strip-It Pro to contact growing plants or areas where bulbs are to be planted.**

### APPLICATION METHODS

Strip-It Pro may be applied by hydraulic sprayer, backpack sprayer, foam applicator, mop or brush. High and low pressure sprayers are recommended for easy removal of debris and rinsing.

Strip-It Pro produces a high foam when used with a foam applicator. Foam is an effective way to clean heavily soiled areas. Foam can be beneficial due to the residual soaking action on both vertical and horizontal surfaces. This soaking action contributes to thorough cleaning results.

### Horticultural Applications

Strip-It Pro may be used in greenhouses, nurseries and exterior building cleaning.

**Areas of Use:** interior and exterior greenhouse structures including glass polyethylene and polycarbonate, storage sheds, pots, plug trays, ground cover, shade cloth, benches, cooling pads, irrigation lines, food-handling equipment and sunblock removal.

Exterior walls of aluminum, wood or brick buildings as well as concrete, gravel, wood or packed soil driveways, walkway and floors of any outdoor covered or uncovered areas.

Safe for cleaning shade cloth, ground cover cloth in greenhouses, shade houses or outdoor growing areas. Use a gentle water rinse when cleaning gravel, ground cover or packed soil growing areas.

### Agricultural Applications

Strip-It Pro may be used on vegetable and fruit farms.

Strip-It Pro has an excellent record as a pre-cleaner for potato storage areas, interior of storage barns, irrigation systems, field equipment and food transportation equipment
